Presidents Review of the Year

We have begun classes for children. The younger group called The Arty Bunch have 17 now on the list working with 3 Adults including Rosalind Crawford the professional artist. We are now going to start a reserve list with a view to starting a second group. The #TAG. Teenage Art Group, for 13 plus teenagers, has also begun and the group of 6 is growing. They are working with Dorothy Black as Tutor.

In the autumn we had a busy programme of classes and workshops and the Spring Programme is about to begin.

A computer for the membership has been introduced, as well as a telephone in the office. These are things which the Club has never had. As another first we have had our Christmas dinner in the Club – a lovely buffet was arranged, and everyone had a lovely day.

Recently the storage areas at the back of the main studio have been converted into two lockable rooms. This is a much safer alternative to several items lying about. We have also had daylight LED lighting installed. This will prove to be a huge benefit to members, particularly in the winter months.

One of the big changes however has been changing the club's legal status to a SCIO (Scottish Charitable Incorporated Organisation). This involved a Special General Meeting last October to accept the change and the adoption of a new constitution.

It has been another busy year but once again I must thank the Committee, now known as the Board of Management, for their hard work. This also goes to the volunteers throughout the year.

Review of Performance and Achievements

• We have successfully applied to OSCR, the charity regulator, to become a Scottish Charitable Incorporated Organisation (SCIO). Effectively a new charity – Glenrothes Art Club (SCIO) – was born on 24 December 2019. A period of transition with both old and new charities operating in tandem has been in place since then. This allows for new business relationships to be established such as with our bank and insurer. The accounts of both charities have been merged for ease of presentation.



- The Glenrothes Art Club shop in the Kingdom Centre continues to be a
 great success with members selling 12 pictures from the shop and it is
 fantastic advertising for the Club when people are browsing in the window
 and see the classes that we are providing.
- This year we started Art Classes for the younger members of the community who are the artists and members of the future. The Arty Bunch for the 8-12years and the # TAG group for Teens, these have proved very successful and they are really enjoying the sessions and have completed some great pieces of work.
- A significant proportion of the sale proceeds from Cottar House have been invested in a term deposit account with Clydesdale Bank. This will pay annual interest of 1.8%. Our first interest payment should be received in the next financial year which will be a welcome boost to our finances.

Treasurers Review of the Year

Our Income & Expenditure Account for 2019/20 is shown at the end of this report, and detailed Notes to these Accounts are on the facing page. These cover relevant accounting policies and highlight significant areas of financial performance. The previous year's figures are included for comparison.

This has been our first full year at Caledonia House, there has been a lot of hard work put in by the Board to try and maximise the enjoyment for the members in the new premises. Significant expenditure on improving the lighting and storage facilities will reap benefits for all members using the Club.

We sold 12 pictures from The Glenrothes Art Centre which has a number of paintings located in the window.

Thank you also goes to our members who organise the raffles and the tea fund which is so important for helping us raise funds and to any members who help with the new young people's art classes they are very considerate in donating their time.

We need to encourage new members to join our club as the fee we charge is very reasonable, we are always keen to hear your views and are looking for people with a passion for the art club and are willing to help us with the day to day running of the club and ideas to attract new members.

We would always like more new members to join our Art Club because without the membership you will not have an Art Club, we need you to invite people to join and enjoy the facilities that are available at the new GLENROTHES ART CLUB

Independent Examiners Report to Trustees/Members of Glenrothes Art Club (SCIO)

I report on the merged accounts of Glenrothes Art Club (SC024072) and Glenrothes Art Club (SCIO) (SC049835) for the year ended 29th February 2020.

Notes to the Accounts

1 Basis of Accounting

These accounts have been prepared on the Receipts & Payments basis in accordance with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

2 Conversion to a SCIO

Following a vote on 6 October 2019 by members of Glenrothes Art Club to convert to a Scottish Charitable Incorporated Organisation (SCIO), our application was approved by the regulator and Glenrothes Art Club (SCIO) came into existence on 24 December 2019.

Since that date we have been in a transition period where both organisations have effectively been running in tandem. Approval has been sought from the regulator to close down the old charity.

For accounting purposes, these are effectively merged accounts covering both Glenrothes Art Club and Glenrothes Art Club (SCIO) for the year reported.

3 Nature and Purpose of Funds

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes. The trustees maintain a single unrestricted fund for the day-to-day running of the club.

Designated funds are unrestricted funds earmarked by the trustees for particular future projects or commitments. The trustees have established one designated fund, where the proceeds from the sale of Cottar House Studio have been earmarked towards future property infrastructure costs - including business rates and property improvements within our new premises.

10 Exceptional Items
