The Charities and Trustee Investment (Scotland) Act 2005 requires the production of a Trustees Report together with the publication of our Annual Accounts. This report meets the requirements of this Act, and the Charities SORP, as they relate to our Club. It is also hoped that it presents a useful insight into the activities and structure of the Club during 2021/22.

#### Aims & Objectives of Glenrothes Art Club (SCIO)

The club aims to promote the benefit of the inhabitants of Glenrothes and its environs and advance the education of the public by:

- Encouraging and facilitating the practice and appreciation of art and craft
- Enabling development of skills and exchange of views and information
- · Creating opportunities for learning
- Providing a regular exhibition programme
- Having working links with other bodies that sustain an arts focus
- Raising funds in support of these aims

Remuneration of Trustees – the trustees did not receive any remuneration during the year in connection with their responsibilities as trustees.

#### **Presidents Review of the Year**

At our last AGM we had several new members come on to the Board. This has resulted in new ideas and new people to take things forward.

We now have a new website which is slowly increasing in numbers visiting and we hope taking an interest in our Club.

We are also using a new system of membership – Membermojo - where members can put in their relevant information and pay their fee online. Of course, should people not wish to do this, they can still write a cheque or give cash to our Treasurer for their six month or annual fee. One of the benefits of Membermojo is that membership reminders for renewal are sent one year or six months from when you paid.

Our new Board members have been thinking and working hard to reach out to people, many of whom do not know we exist. Courses have been arranged by Board Members and advertised through Eventbrite which reaches a far wider audience. So far, the courses have been successful, and we have gained a few new members as a result.

After lockdown etc we began our classes for young people again. The Arty Bunch has very good attenders and we even have a waiting list. We hope to attract more members to the #TAG group and hope that the members of both these groups will carry on with their artwork and continue to be affiliated to the Art Club.

Despite Covid and its restrictions we still managed to organise sales tables in the Rothes Halls which were very successful due to the commitment of the helpers. We also raised money when Glenrothes Foodbank had their Christmas Fayre and people were able to come in to see the facilities we have to offer.

I think we can look back and be proud of the year we have had. We know there is still a lot of work to be done and we hope that our membership will support us in any way they can as, after all, the club is for them to enjoy artistically and socially.

#### **Review of Performance and Achievements**

- The Scottish Government continued to provide coronavirus support in the form of 100% relief from Business Rates. In addition, we were able to claim £19,000 in Covid Recovery funding early this year.
- We were also delighted to receive £1,352 in financial support from Diageo and £250 from FiFab to help pay for the opening of our annual exhibition.





- We were able to get back to holding our annual exhibition at the Rothes Halls this year. A splendid variety of artwork, both paintings and craft, were on display. Footfall was less than in previous years, but with little activity going on in the Halls and Covid precautions still in place this was probably to be expected.
- Our art classes for the younger members of our community have remained popular. The Arty Bunch for 8-12 years and the #TAG for teenagers have managed to operate for much of the year.
- Our programme of workshops and classes continues to grow and develop. Blocks of classes covering printmaking and basic drawing skills are always popular. A variety of workshops on different topics have been run and continue to grow. Parent-and-child workshops have been run on a variety of seasonal subjects such as Halloween and Christmas. We are now using an online booking tool – Eventbrite – to manage our programme. This streamlines the process and makes it easier to run a number of workshops at the same time.
- We have a new website, a new logo, and we are using online tools such as Membermojo and Eventbrite to give a fresh, new look to the Art Club. We need to attract new members to the Club, as well as increase the revenue from our workshop programme, and it is hoped that these developments will help us generate more members and revenue, whilst ensuring we are capable of managing any increase.

#### Treasurers Review of the Year

Our Accounts for 2021/22 are shown at the end of this report, along with detailed Notes to these Accounts. These cover relevant accounting policies and highlight significant areas of financial performance. The previous year's figures are included for comparison.

This financial year is of course affected by the second year of the coronavirus pandemic – the impact of lockdowns is clear to see, however the impact since lockdowns is more difficult to assess at this time.

The Notes to the Accounts identify a number of exceptional items in this year's accounts. These have impacted on both income and expenditure, and as such there is a degree of offsetting.

The exceptional items help to explain the significant deficit incurred this year, which is of no surprise given the expected impact of back-dated rent payments, together with the rental cost for the accounting year itself.

Our savings bond reached the end of its two-year term and has been closed during the year, simplifying our banking arrangements.

Our balance on 28 February 2022 is £77,622 which is healthy in terms of our short-term annual costs, but much work lies ahead in terms of increasing our income from memberships and our workshop programme.

## Independent Examiners Report to Trustees/Members of Glenrothes Art Club (SCIO)

I report on the accounts of Glenrothes Art Club (SCIO) (SC049835) for the year ended 28<sup>th</sup> February 2022.

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006. The procedures undertaken do not provide all the evidence that would be required in an audit and, consequently, I do not express an audit opinion on the accounts.

#### Notes to the Accounts

#### 1 Basis of Accounting

These accounts have been prepared on the Receipts & Payments basis in accordance with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

#### 2 Conversion to a SCIO

Following a vote on 6 October 2019 by members of Glenrothes Art Club to convert to a Scottish Charitable Incorporated Organisation (SCIO), our application was approved by the regulator and Glenrothes Art Club (SCIO) came into existence on 24 December 2019.

Following approval by the regulator, the old charity was officially closed down on 28 September 2021.

#### 3 Nature and Purpose of Funds

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes. The trustees maintain a single unrestricted fund for the day-to-day running of the club.

Designated funds are unrestricted funds earmarked by the trustees for particular future projects or commitments. The trustees have established one designated fund, where the proceeds from the sale of Cottar House Studio have been earmarked towards future property infrastructure costs - including business rates and property improvements within our new premises.
