- Creating opportunities for learning
- Providing a regular exhibition programme
- Having working links with other bodies that sustain an arts focus
- Raising funds in support of these aims

Recruitment of Trustees – all of the trustees are appointed or reappointed by the members at our Annual General Meeting which is normally held in Spring each year.

Remuneration of Trustees – the trustees did not receive any remuneration during the year in connection with their responsibilities as trustees.

Presidents Review of the Year

The Art Club has had a good year attracting several new members. We have had a lot of success with various classes - Dot Black's evening classes for adults; her monthly workshops for adults with special needs and the Arty Bunch weekly classes for children aged 8-12 years. Unfortunately, the teenage group has been dropped for the moment as we don't have enough students, nor do we have a tutor. But we hope to resume at some point.

We also had an interesting and humorous evening with a poetry reading by Ian Nimmo White, the proceeds of which he donated to The Ukraine Crisis Relief Fund.

Our Annual Exhibition was held in November this year in the Rothes Halls. Sales were down but that was entirely expected in the current financial climate.

We had a table outside the Art Club when the Food Bank had their Christmas Fair. This also gave us the opportunity to show any interested people around and tell them about the club. We made some good sales when we had tables in the town centre just outside the Rothes Halls.

We look forward to continuing these successes next year.

Review of Performance and Achievements

- We have been developing a significant programme of art workshops this
 year for adults with special needs. This is being funded by Promoting A
 More Inclusive Society (PAMIS) on an event-by-event basis. Due to the
 success of this programme, we have received grant funding of £1,500 from
 The Art Society Fife to run a similar programme for children during 2023.
- Our annual exhibition was held at the Rothes Halls again this year. A
 fantastic variety of artwork, both paintings and craft, were on display. A
 grant of £250 from FiFab helped pay for the opening of the exhibition as
 well as some advertising costs.

- Our art classes for the younger members of our community have remained popular. The Arty Bunch for 8-12 years and the #TAG for teenagers have managed to operate for much of the year. Several of our young artists exhibited their work as part of our annual Club exhibition this year.
- Our programme of classes continues to grow and develop. Several programmes for beginners have been run on Thursday nights.
- An evening of Poetry and Short Stories by local poet Ian Nimmo White was held in late Summer, principally to raise funds for the Ukraine Crisis Relief Fund. A total of £105 was raised, and a very pleasant evening was enjoyed by several members and guests.

Treasurers Review of the Year

Our Accounts for 2022/23 are shown at the end of this report, along with detailed Notes to these Accounts. These cover relevant accounting policies and highlight significant areas of financial performance. The previous year's figures are included for comparison.

A deficit of £11,840 is recorded in this financial year, with no exceptional items to report. Both income and expenditure have returned to pre-pandemic levels.

Our balance on 28 February 2023 is £65,782 which is healthy in terms of our short-term annual costs, but work continues to lie ahead in terms of increasing our income from memberships and our workshop programme.

Independent Examiners Report to Trustees/Members of Glenrothes Art Club (SCIO)

I report on the accounts of Glenrothes Art Club (SCIO) (SC049835) for the year ended 28th February 2023.

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and, consequently, I do not express an audit opinion on the accounts.

In the course of my examination, no matter has come to my attention:

Notes to the Accounts

1 Basis of Accounting

These accounts have been prepared on the Receipts & Payments basis in accordance with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

2 Nature and Purpose of Funds

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes. The trustees maintain a single unrestricted fund for the day-to-day running of the club.

Designated funds are unrestricted funds earmarked by the trustees for particular future projects or commitments. The trustees have established one designated fund, where the proceeds from the sale of Cottar House Studio have been earmarked towards future property infrastructure costs - including business rates and property improvements within our new premises.
