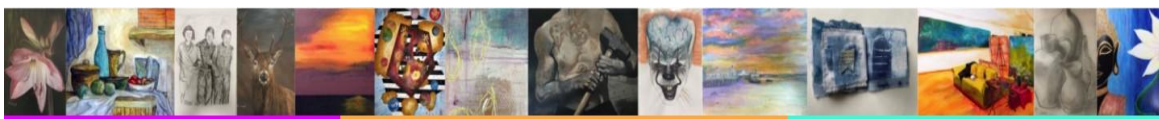

Presidents Review of the Year

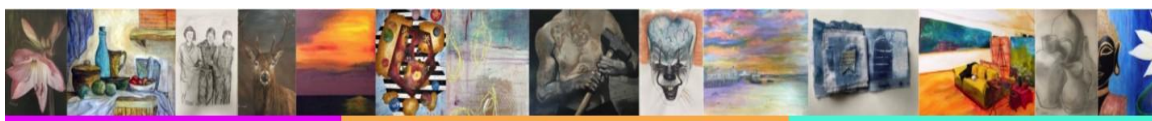
The Art Club has had a good year attracting several new members. We continue to have a lot of success with various classes - the monthly PaMIS workshops for adults and young people with special needs and the Arty Bunch weekly classes for children aged 8-16 years. Our Adult classes on a Tuesday evening have been running more regularly this year.

Our Annual Exhibition was in the Rothes Halls this year. It ran for several months with a new approach to sales, and overall, the exhibition was deemed a great success in what was our 70th year.

We also made some excellent sales when we had craft tables in the town centre just outside the Rothes Halls.

We look forward to continuing these successes going forward.

Review of Performance and Achievements

- Our annual exhibition was held in the Rothes Halls again this year. A great variety of artwork, both paintings and craft, were on display, and sales were significantly higher than previous years
- Our art classes for the younger members of our community have remained popular. The Arty Bunch for 8-16 years has operated for most of this year.
- We have continued to develop a significant programme of art workshops this year for adults with special needs. This is being funded by Promoting A More Inclusive Society (PAMIS) on an event-by-event basis. Due to the success of this programme, we received further grant funding of £500 from The Art Society Fife. It is hoped that funding will continue to allow these events to continue through 2026. Grant funding from FiFab of £250 has also contributed to the success of this programme.

Treasurers Review of the Year

Our Accounts for 2025/26 are shown at the end of this report, along with detailed Notes to these Accounts. These cover relevant accounting policies and highlight significant areas of financial performance. The previous year’s figures are included for comparison.

A deficit of £9,492 is recorded in this financial year.

Our financial position has improved through this year, due to consistent levels of attendance at our workshops and a healthy level of sales at our Exhibition. These both bode well for the future. Another factor is the low level of expenditure on Gas – due to over-charging in the previous year by our supplier, It is hoped that this core item of expenditure will stabilise going forward.

Our balance on 28 February 2026 is £22,917 which is reasonable in terms of our short-term annual costs, but work continues to assess the future of the Art Club beyond 2026, when we reach a break clause in the lease for our accommodation.

Independent Examiners Report to Trustees/Members of Glenrothes Art Club (SCIO)

I report on the accounts of Glenrothes Art Club (SCIO) (SC049835) for the year ended 28th February 2026.

The charity's trustees are responsible for the preparation of the accounts in accordance with the terms of the Charities and Trustee Investment (Scotland) 2005 Act and the Charities Accounts (Scotland) Regulations 2006. The charity trustees consider that the audit requirement of Regulation 10(1)(d) of the Accounts Regulations does not apply. It is my responsibility to examine the accounts as required under section 44(1)(c) of the Act and to state whether particular matters have come to my attention.

My examination is carried out in accordance with Regulation 11 of the Charities Accounts (Scotland) Regulations 2006. An examination includes a review of the accounting records kept by the charity and a comparison of the accounts presented with those records. It also includes consideration of any unusual items or disclosures in the accounts and seeks explanations from the trustees concerning any such matters. The procedures undertaken do not provide all the evidence that would be required in an audit and, consequently, I do not express an audit opinion on the accounts.

Notes to the Accounts

1 Basis of Accounting

These accounts have been prepared on the Receipts & Payments basis in accordance with the Charities and Trustee Investment (Scotland) Act 2005 and the Charities Accounts (Scotland) Regulations 2006 (as amended).

2 Nature and Purpose of Funds

Unrestricted funds are available for use at the discretion of the trustees to further any of the charity's purposes. The trustees maintain a single unrestricted fund for the day-to-day running of the club.

Designated funds are unrestricted funds earmarked by the trustees for particular future projects or commitments. The trustees had established one designated fund, where the proceeds from the sale of Cottar House Studio were earmarked towards future property infrastructure costs.

Given the limited resource remaining in this Designated Fund, the trustees have closed this Fund, and the balance of £8,581 has been transferred to the General Fund. Any future property infrastructure costs will be charged against the General Fund.
